Cache Mosquito Abatement District Board of Trustees Meeting September 26, 2024

MEETING CALLED TO ORDER AND ROLL CALL

The meeting was called to order at 7:00 p.m. by Chair Joe Hansen and roll call was recorded.

ADOPT AGENDA

The agenda was reviewed.

MINUTES OF PREVIOUS MEETING

The minutes of the August 22, 2024 meeting were reviewed.

CPA REPORT

Matt Regan came and reported on the 2023 Financial Report. He gave everyone copies and Cache Mosquito Abatement District is in compliance and is in good report.

TAX INCREASE DISCUSSION

We broke down the points that need to be covered and are necessary for CMAD to raise taxes.

- A) INTENT TO INCREASE- Cache Mosquito Abatement declares the intent to increase taxes
- B) DOLLAR AMOUNT OF INCREASE- \$100,000

- C) PURPOSE FOR INCREASE- Cache Mosquito Abatement District's reason for raising taxes is Competitive labor rates make competent workers harder to find at current wages. Chemical prices have continued to increase by an average of 33% in the last six years. Volatility of fuel prices which have seen a 45% increase in the last five years. Vehicle and utility vehicle prices are skyrocketing (at least 30% over the last six years). Chemical usage in neighboring communities limits chemical choices due to chemical resistance. Equipment (i.e., larger drones, new foggers, backpack sprayers, etc.) cost more to replace. Local population growth will be the biggest issue leading to the likelihood of requiring spraying five nights a week
- D) APPROXIMATE PERCENTAGE OF INCREASE- 25.37%

MANAGER AND CLERK REPORTS

Manager Richard Rigby reported that numbers have significantly gone down. This week was the last week for traps, and September 26th was the last night of spraying. Many towns got tested for West Nile due to the weather this year. We had one case of neuroinvasive in Cornish, but we don't know any other information. Birds are the carriers of West Nile, and one reason we didn't see it earlier this year was due to the bird migration. Humans are dead-end hosts, so once a mosquito bites a human, the virus's lifecycle ends. 3 weeks ago, we found a leak in the locker room. At first, we thought it was coming from the floor and were worried it was from a spring, but we found a pinhole in an elbow up in the ceiling. The water was running down the metal stud and exiting at the bottom. We filed a claim, which we have a \$1000 deductible on the building which will be cheaper than the repairs. BlueSky is working on the repairs.

Clerk Sierra Bradley had nothing to report for this meeting.
